BY THE COMMISSION:

The Commission opened this docket on its own motion on March 17, 2009 in order to receive and monitor filings regarding gas supply cost adjustment schedules filed by Source Gas Distribution LLC (SourceGas) pursuant to *Neb. Rev. Stat.* § 66-1854.

Pursuant to the Commission's general grant of authority and its power to audit, the Commission conducted an informal review of SourceGas' GSCA. Furthermore, the Commission's consultants conducted an on-site review on September 22 through 24, 2009.

A copy of the consultant's initial findings shall be made available to SourceGas for comment prior to the issuance of the Commission's final order and report. SourceGas shall submit written comments on or before **5:00 p.m. on February 5, 2010.**

Based upon the initial findings, the Commission finds it necessary to schedule a hearing on the matter to determine the basis for the apparent discrepancy and to adopt an appropriate remedy. Therefore, hearing on this matter is scheduled for **February 10, 2010, at 1:30 p.m. CST** in the Commission Hearing Room, 300 The Atrium, 1200 N Street, Lincoln.

Subsequently, the Commission shall review the initial findings of the consultant, the comments filed by SourceGas, and evidence adduced at the hearing and will issue a final order regarding the review.

ORDER




